

ReNew Power bags the highest subsidy allocation from SECI for rooftop solar projects

- ReNew Power has been allocated 49 MW under SECI's rooftop solar mega tender of 500 MW
- Approx. 130 bidders participated and ReNew Power won 10% of the total bid capacity
- The solar rooftop projects will be targeted towards institutional as well as residential sector installations
